

NOTICE**SCHOLARSHIP FOR 1ST SEMESTER STUDENTS (EXCEPT MBA)**

Applications are invited from eligible students of 1st semester of the University (Except MBA) for **Loyola Scholarship and Britto Scholarship**.

Scope of the scholarship:

Loyola Scholarship - 100% scholarship (tuition fees waiver only)

Benevolent requirement:

- Family income is less than 25000 per month or 300000 per year
- For wards of retired/martyred defence, police and paramilitary personnel, Family income is less than 30000 per month or 360000 per year

Britto Scholarship - 50% scholarship (tuition fees waiver only)

Benevolent requirement:

- Family income is less than 30000 per month or 360000 per year
- For wards of retired/martyred defence, police and paramilitary personnel, Family income is less than 35000 per month or 420000 per year

Academic Requirement (for both Loyola and Britto):

- 60% in all preceding qualifications (such as 10th , 12th or graduation)
- 60% in all preceding semester of the current degree program
- No arrear paper in any preceding semester of the current degree program
- Minimum 75% attendance in all preceding semesters of the current degree program

Processes of Application:

Online Application: Application for scholarship will be accepted only in online form through the student portal. No other mode of application will be accepted.

Last date for online application is 7th February 2021

(Applicants need to take printout of the application and send it to The Assistant Registrar along with all supporting documents. Application will liable to be cancelled if printout is not received within specified time.)

Last date for receipt of printout of the aforementioned application along with all supporting documents is 14th February 2021

Supporting Document to be uploaded during application and self-attested copy to be submitted in hard copy:

1. Proof of admission to respective course at St. Xavier's University
2. Marksheet and Certificate of Secondary, higher secondary.
3. Final Marksheet and Certificate of Graduation (For Masters students only)
4. Income Proof : Salary Slip, IT Return and Bank account statement of both the parents or guardian.

Note:

1. Possessing of mere eligibility does not ensure grant of scholarship
2. The decision of the Vice-Chancellor of the University shall be final and binding with respect to grant of scholarship.
3. Any canvassing by or on behalf of the candidates with regard to their selection for the above scholarship shall be considered as disqualification.
4. Incomplete application with/without supporting documents will be summarily rejected.
5. The scholarship committee reserves the right to review, modify or cancel the award due to changes in academic progress or general conduct of the student in accordance with the University rules and regulations.
6. If the candidate is found to furnish any false information or recommended for any disciplinary action by the disciplinary committee at any stage of the course, his/her scholarship may stand revoked.
7. Applications received after the due date will not be considered.
8. The University shall not be responsible for any postal delay.
